February 14, 2020

Deadline for the Settlement Class to Comment upon or Object to the Proposed Settlement; Deadline to file any response or objection to the Application for Attorneys' Fees and Expenses, and Service Awards for Plaintiffs.

February 21, 2020

Deadline for Filing All Final Papers in Support of Motion for Final Approval, Attorneys' Fees and Expenses, and Service Awards for Plaintiffs, and for the Parties to Respond to Any Comments or Objections.

March 2, 2020

The Final Fairness Hearing is scheduled on March 2, 2020, at 9:00 am before United States District Judge Amos Mazzant at the Paul Brown Courthouse, 101 E. Pecan Street, Sherman, Texas 75090.
