**ORDER**

On November 21, 2019, the parties filed a Joint Notice of Settlement and Request for Entry of Case Management Deadlines (the “Notice”) (Dkt. 256). In accordance with the parties’ request, the Court sets the following deadlines. The parties have conferred regarding the dates and deadlines herein and are in agreement as to the dates submitted to the Court for approval.

<b>December 10, 2019</b>	Deadline for the Parties to File Joint Motion for Preliminary Approval.
<b>December 27, 2019</b>	Deadline for CAFA Notice
<b>January 16, 2020</b>	Deadline for Mailing of Class Notice and Posting Class Notice to Website
<b>January 17, 2020</b>	Deadline for Filing Motion for Final Approval, Attorneys’ Fees and Expenses, and Service Awards for Plaintiffs (45 days prior to the Proposed Fairness Hearing)
<b>February 3, 2020</b>	Deadline for the Settlement Class to Comment upon or Object to the Proposed Settlement (28 days prior to the Proposed Fairness Hearing)

**February 21, 2020**

Deadline for Filing All Final Papers in Support of Motion for Final Approval, Attorneys' Fees and Expenses, and Service Awards for Plaintiffs, and for the Parties to Respond to Any Comments or Objections (10 days prior to the Proposed Fairness Hearing)

**March 2, 2020**

Fairness Hearing at **9:00 a.m.** before United States District Judge Amos Mazzant at the Paul Brown United States Courthouse, 101 E. Pecan Street, Sherman, Texas 75090.  
(75 days after anticipated Order on Preliminary Approval)

If any deadline set forth in this Order falls on a Saturday, Sunday or federal holiday, the deadline shall be extended to the next Court business day. The Court reserves the right to adjust the date of the Final Approval Hearing and related deadlines. In that event, the revised hearing date and/or deadlines shall be posted on the Settlement Website referred to in the Notice, and the parties shall not be required to re-send or republish the Notice.
